Phytosanitary requirements for corn seeds (Zea mays spp) for import into the territory of the Republic of Uzbekistan.

Regulated products imported into the territory of the Republic of Uzbekistan must be free from quarantine objects included to the List of pests, plant diseases and weeds of quarantine importance for the Republic of Uzbekistan.

1. Imported seeds must be free of soil and other foreign bodies.

2. Each package of regulated products must be labeled containing information about the product name, country of origin, exporting country and (or) reexporting country.
