

**Information
on special quarantine phytosanitary requirements for import
of pistachio seedlings to the Republic of Uzbekistan.**

1. Quarantine products imported into the territory of the Republic of Uzbekistan must be free from quarantine objects included in the list of pests, plant diseases and weeds of quarantine importance for the Republic of Uzbekistan.
2. Imported seedlings must be free of soil and other foreign bodies
3. Pistachio seedlings imported into the territory of the Republic of Uzbekistan must be free from: *Pseudococcus citriculus*, *Ceratitis capitata* Wied., *Ceratitis rosa* Walk., *Dacus dorsalis* Hend., *Pseudauleacapsis pentagona*, *Liriomyza trifolii*, *Halymorpha halys*, *Liriomyza huidobrensis*, *Carposina niponensis*, *Conotrachelus nenuphar*, *Grapholitha molesta*, *Quadraspidiotus perniciosus*, *Hyphantria cunea*, *Phymatotrichopsis omnivora*, American plum line pattern virus, *Erwinia amylovora*, Peach rosette mosaic nepovirus, Peach mosaic virus (American), *Erwinia amylovora* Peach rosette mosaic nepovirus and other harmful organisms that are potentially harmful to the flora of Uzbekistan, and must also be fumigated by chemical treatment.
4. Each package of regulated products must be marked with information on the name of the product, its country of origin, exporting country and (or) reexporting country.
5. In case of detection of signs of infection by pests of plant quarantine in samples of quarantine products, they are transferred to the appropriate quarantine laboratories for study. If quarantine and other dangerous pests, plant diseases and weeds are found in these samples, they must be fumigated or returned to the shipper, if it is impossible to return to the shipper, they must be destroyed. A separate act is drawn up by the state plant quarantine inspector about this and sent to the interested parties within three working days.
6. If it is impossible to apply effective fumigation and cleaning measures in relation to regulated products infected with quarantine and other dangerous pests, plant diseases and weeds, they must be returned to the exporting country in accordance with the established procedure or destroyed (by burning or burying in the ground in a specially designated place).

on special quarantine phytosanitary requirements for import
of olive seedlings to the Republic of Uzbekistan - *Olea europaea*.

1. Imported seedlings must be free of soil and other foreign bodies.
2. Olive seedlings imported into the territory of the Republic of Uzbekistan must be free from: *Pseudococcus citriculus*, *Aleurocanthus woglumi*, *Ceratitis capitata* Wied., *Ceroplastes rusci*, *Ceratitis rosa* Walk., *Lopholeucaspis japonica*, *Dacus dorsalis* Hend., *Pseudauleucaspis pentagona*, *Liriomyza trifolii*, *Halymorpha halys*, *Liriomyza huidobrensis*, *Carposina niponensis*, *Conotrachelus nenuphar*, *Grapholitha molesta*, *Quadraspidiotus perniciosus*, *Hyphantria cunea*, *Phymatotrichopsis omnivora*, American plum line pattern virus, *Erwinia amylovora*, Peach rosette mosaic nepovirus, Peach mosaic virus (American), Plum pox virus and other harmful organisms that are potentially harmful to the flora of Uzbekistan, and must also be fumigated by chemical treatment.
3. Each package of regulated products must be marked with information on the name of the product, its country of origin, exporting country and (or) reexporting country.
4. Import is allowed in case the batch of quarantine products is fumigated and the appropriate record about the fumigation is noted in the phytosanitary certificate.
5. Consignments (part of a consignment) of imported planting material, in which quarantine objects have been identified, are subject to return or destruction.

on special quarantine phytosanitary requirements for import
of Citrus and Kiwi seedlings to the Republic of Uzbekistan.

1. Quarantine products imported into the territory of the Republic of Uzbekistan must be free from quarantine objects included in the list of pests, plant diseases and weeds of quarantine importance for the Republic of Uzbekistan.
2. Imported seedlings must be free of soil and other foreign bodies.
3. Citrus seedlings imported into the territory of the Republic of Uzbekistan must be free from: *Aceria sheldoni* (Ewing), *Aleurocanthus woglumi* Ash., *Aleurothrixus floccosus* Mask., *Aonidiella aurantii* Mask., *Ceratitis capitata* Wied., *Ceratitis rosa* Walk., *Lopholeucaspis japonica* Ckll., *Pseudococcus gahani* Green., *Unaspis yanonensis* Kuw., *Tetradacus citri*, *Carposina niponensis*, *Unaspis citri*, *Aonidiella citrina* Coq., *Chlonaspis furfure* Fitch., *Diaphorina citri* Kuway, *Pseudauleucaspis*

pentagona Targ., *Dacus dorsalis* Hend., *Halyomorpha halys*, *Aleurocanthus spiniferus* Quaint., *Xanthomonas campestris* pv. *citri*, *Citrus tristeza virus* and other harmful organisms that are potentially harmful to the flora of Uzbekistan, and must also be fumigated by chemical treatment.

4. Each package of regulated products must be marked with information on the name of the product, its country of origin, exporting country and (or) reexporting country.
5. In case of detection of signs of infection by pests of plant quarantine in samples of quarantine products, they are transferred to the appropriate quarantine laboratories for study. on special quarantine phytosanitary requirements for import
of hazelnut seedlings to the Republic of Uzbekistan - *Corylus*.**

1. Quarantine products imported into the territory of the Republic of Uzbekistan must be free from quarantine objects included in the list of pests, plant diseases and weeds of quarantine importance for the Republic of Uzbekistan.
2. Imported seedlings must be free of soil and other foreign bodies.
3. Citrus seedlings imported into the territory of the Republic of Uzbekistan must be free from: *Aleurocanthus woglumi* Ash., *Numonia pyrivorella*, *Ceroplastes rusci*, *Conotrachelus nenuphar*, *Pseudococcus citriculus*, *Halymorpha halus*, *Ophiognoma leptostyla*, *Phomopsis juglandina*, *Pseudomonas syringae* pv. *syringae*, *Xanthomonas arboricola* pv. *Corylina*.
4. Each package of regulated products must be marked with information on the name of the product, its country of origin, exporting country and (or) reexporting country.
5. In case of detection of signs of infection by pests of plant quarantine in samples of quarantine products, they are transferred to the appropriate

quarantine laboratories for study. If quarantine and other dangerous pests, plant diseases and weeds are found in these samples, they must be fumigated or returned to the shipper, if it is impossible to return to the shipper, they must be destroyed. A separate act is drawn up by the state plant quarantine inspector about this and sent to the interested parties within three working days.

6. If it is impossible to apply effective fumigation and cleaning measures in relation to regulated products infected with quarantine and other dangerous pests, plant diseases and weeds, they must be returned to the exporting country in accordance with the established procedure or destroyed (by burning or burying in the ground in a specially designated place).
